Overview of MARRT

The Manitoba Association of Registered Respiratory Therapists (MARRT) has been granted the authority by the provincial government to regulate the practice of Respiratory Therapy in Manitoba. The regulatory body has the mandate to protect the public by ensuring respiratory therapists meet the necessary requirements to hold a valid license to practice, and that they practice competently and safely. MARRT functions under provincial legislated statutes detailing the composition and responsibilities of the MARRT.

The National Competency Framework (NCF) details the core and clinical competencies, performance criteria, knowledge, and skills that an individual must acquire for entry to practice. It defines the scope of practice capacity of a respiratory therapist on a national scale. RRTs must practice within these parameters. Individual employers define the employment scope that outlines the duties and responsibilities of a RRT within their place of employment.

The MARRT Code of Ethics and Standards of Practice direct members in providing professional, competent, and safe respiratory care.

MARRT Website

The website (https://www.marrt.org/) is a resource where members and the public can access information. It includes the mission and values statement as well as the strategic priorities. You can also access documents pertaining to the governance of the profession and your professional responsibilities.

- The education tab explains the continuing competency requirements and provides educational resources and opportunities.
- The licensing section explains the necessary requirements and steps to become a licensed member of MARRT.

The members' section is the portal to your personal account. It includes your user profile, event registrations, and invoices.

Becoming a Registrant

How do I apply for a license?

First you must create a user profile within the MARRT online data management system. Once this is done complete the online application form. There are two practicing membership categories to choose from upon applying for license.

- 1. Active Practicing: being those persons who have successfully completed a board recognized credentialing examination, and who meet the requirements for licensure as a full active practicing member.
- Active Practicing with Graduate Conditions: being those persons who have successfully
 completed their education and have yet to successfully challenge a board recognized
 credentialing examination.

Once completed and the application fee has been submitted, the Registrar will begin the process of reviewing your completed application.

What does it cost for a license to practice in Manitoba?

What do I do if I have questions or am having difficulty with the application process?

If at any time you have questions, please contact the Registrar at edregistrar@marrt.org.

How long does the process normally take to become licensed?

Once the required steps have been completed, the license approval will normally occur within 5 working days. This time frame may vary if the Registrar requires additional information or documentation from the applicant.

Once all requirements have been met and the application is approved, the Registrar will add the applicant to the Active Practicing membership roster. Please note that the license will be restricted, and the new member will be unable to practice until fee payment has been received.

Am I required to purchase Professional Liability Insurance?

A Registered Respiratory Therapist practicing in Manitoba must secure a minimum of \$5,000,000 per claim and or \$10,000,000 aggregate per year Professional Liability Insurance. They must be in possession of this on their first day of employment and continue to hold insurance while they are employed.

I have made an error in the disclosure statements section. What do I do?

Please contact the Registrar as these fields cannot be edited by the user. As the answers may affect your eligibility for licensure, it is important to do this as soon as you are aware of the error so as to allow the license application process to continue.

What additional information is required if I am applying from another jurisdiction?

Before the application for licensure with MARRT can be completely evaluated, a Registration Verification Form must be completed. You must complete Section 1 of the form and submit it to your current regulatory body for completion of Section 2. Your current regulatory body will forward the completed form to the MARRT Registrar.

What record checks am I required to provide?

As per policy L-11, applicants are required to submit the following record checks to the MARRT Registrar:

• Criminal Record Check & Vulnerable Sector Check

Adult & Child Abuse Registry Check

- o Completed online here.
- o Both an Adult & Child check must be completed

For new applicants to the MARRT, the date the check was completed must be six months or less from the date it is submitted to the MARRT. *All* checks are valid for five years from the completed date of the Criminal Record Check and Vulnerable Sector Check.

Additional requirements for graduate applicants

I am a graduate respiratory therapist from another province. Am I eligible for licensure in Manitoba?

To be eligible for licensure in Manitoba you must have successfully completed an accredited respiratory therapy educational program.

Are there additional requirements that a graduate respiratory therapist must submit?

Yes. Proof of successful completion, in the form of an official letter from the educational institution, must be sent to the Registrar before the application can be completely evaluated.

What type of license category will I be granted?

You will be placed in the Active Practicing Graduate license category.

Are there conditions on the graduate license?

Yes. There are practice conditions that you must abide by until such time as you successfully complete the MARRT credentialing examination. Please refer to the <u>L-04 Graduate Respiratory Therapist Policy</u>.

What is the MARRT credentialing examination?

The MARRT credentialing examination is one of the recognized national certification exams that must be successfully challenged before an individual can practice without graduate conditions on their license. MARRT has a contract with the Health Professionals Testing Canada Inc (HPTC) to provide the examination.

When completing the HPTC application form for the MARRT credentialing examination, please ensure that you check off the box labeled "MARRT Registration Examination". This action allows the HPTC to release the results of the examination to the MARRT.

I have successfully challenged the credentialing examination. How do I have the graduate conditions removed from my license?

It is your responsibility to notify the MARRT Registrar and provide written proof that you have passed the credentialing examination. Only once this is communicated will the graduate conditions be lifted.

- The document must be on the HPTC's letterhead and have the signature of the Executive Director or designate.
- Following receipt of the document, you will then be granted a full active practicing license with no conditions or restrictions.
- You must notify your employer of the change in status of your practice license.

I was unsuccessful in my attempt at passing the credentialing examination. What do I need to do? It is your responsibility to notify the Registrar and provide the written document detailing your examination results.

- The document must be on the HPTC's letterhead and have the signature of the Executive Director or designate.
- You must notify your employer that you were unsuccessful in your attempt.

Can I still work as a graduate respiratory therapist?

Yes. You may continue to be employed as a graduate respiratory therapist while functioning under the conditions detailed in the graduate license conditions policy.

When renewing your license, you must specify the date of the unsuccessful attempt at the examination in the field provided.

How many attempts am I allowed at challenging the credentialing examination?

You can challenge the credentialing examination three times. This must occur within eighteen months from your first attempt. If you are unsuccessful three times you are no longer eligible for licensure to practice Respiratory Therapy.

International Applicants

How do I become licensed in Manitoba if I am an internationally educated respiratory therapist?

The application process is the same as for a domestically educated respiratory therapist. In addition, your credentials and the related competencies that you possess will need to be evaluated. More information can be found here.

License Renewal

How long is my license to practice valid?

The MARRT licensing year runs February 1 to January 31 and must be renewed annually.

When is the expiry date?

All categories of licenses granted expire at midnight, January 31 of each year.

When can I renew my license?

Licensure renewal opens on December 1 annually. There are no additional fees applied if completed on or before January 15.

How do I complete the renewal?

The renewal process is accessed through your personal member portal.

- Logon to your personal member portal by using your username and password. If you have forgotten your password, follow the instructions for "password retrieval" at the bottom of the login screen;
- Complete the e-learning module; and
- Click "license renewal" and proceed with providing the required information and payment of fees.

What do I do if my surname or address has changed?

It is the member's responsibility to ensure demographics are accurate and current. Whenever there is a change, the user's profile must be updated to reflect the new information. Examples are home address, email address, telephone number, name change, employment facility, etc.

How do I pay my license fees?

A valid VISA or Mastercard is required for payment of all MARRT associated fees.

Can I use the time payment option offered by CSRT?

Yes, the MARRT accepts payment of license fees via the CSRT payment plan. Please note that the CSRT deadline for payment plan option is earlier than MARRT deadline - https://www.csrt.com/join/

Please note the following important points:

- You must still complete the MARRT online renewal process though your personal member portal.
- 2. Choose INVOICE ME instead of PAY NOW when prompted for credit card information.
- 3. The deadline for renewals without a late fee still applies when using this method.

What is the deadline for MARRT license renewal?

The deadline for renewal without penalty to be submitted is midnight January 15.

What are the late fees?

A late fee of \$150 is applied if renewal is received between January 16 – 31.

What happens if I have not renewed my license by midnight on January 31?

An individual practicing without a valid approved license is in contravention of The Registered Respiratory Therapists Act.

The license to practice has lapsed and you must reapply for practice by requesting reinstatement. The reinstatement fee of \$75 will be applied <u>in addition</u> to the late fee <u>and</u> the license fee.

Does MARRT prorate license fees?

The MARRT prorates license fees on a quarterly basis. The quarters are February 1 to April 31, May 1 to July 31, August 1 to October 31, November 1 to January 31.

Does MARRT provide rebates on license fees if I am no longer going to practice in Manitoba? No. MARRT does not provide rebates on fees.

Will I receive confirmation that my renewal is complete?

Once the license fee has been received, the Registrar will review and approve the license renewal. Once finalized, your receipt for payment will be in your user profile under the invoice tab. A registration card will be emailed to you as well.

I am planning on going on a leave of absence in the upcoming license year. What can I do regarding licensure?

There are three options to consider:

- 1. Inform the Registrar of the planned start date of the leave of absence at renewal. The license fee for the upcoming year will be prorated based on which quarter you leave practice. Effective the date your leave commences, your license will be changed to Inactive Practicing. Upon planned return, you must contact the Registrar 6 8 weeks prior to your return-to-work date to ensure all requirements for the reinstatement of your license are complete. You will be charged a Reinstatement Fee and the applicable license fees will be calculated based on the quarters remaining in the license year.
- 2. Maintain an active practicing license and pay the required license fee.

Inactive Practicing registrants cannot legally practice and must maintain the expected continuing competency requirements as described in the regulations.

Maintenance of Eligibility to Practice

How do I maintain eligibility for practice?

A Registered Respiratory Therapist must have worked 720 hours total in the 4 years prior to the year licensure is being sought.

What is an e-learning module?

The E-learning module is a compulsory educational module which must be completed prior to the license renewal form being accessible. The module is:

- A series of multiple-choice questions that are based on regulatory governance and includes important information relevant to changes in practice.
- **Not** a pass / fail format, but the correct answer must be chosen before the module will advance to the next question.
- It may also be a series of informative videos that you are required to view with no multiplechoice questions.

What is the MARRT Continuing Competency Program (CCP)?

The CCP is a program, implemented by the MARRT, to ensure members practice lifelong learning and undergo additional education and skills acquisition to ensure that competent care is being delivered based on best evidence.

The CCP provides quality assurance that RRTs are providing competent, safe care to the public by ensuring ongoing education. According to the Registered Respiratory Therapists Regulations, each member must achieve 24 credit hours of recognized categories in each calendar year.

What is the random audit?

The audit is a review of 10% of randomly selected MARRT registrants' professional portfolios. It is performed annually in March to ensure compliance with the CCP. Randomly selected members are asked to submit their portfolios containing the continuing education that they participated in the last calendar year. What happens if I am experiencing difficulties completing the requirements during the license year or I am unable to submit my portfolio by the requested date?

- If at any time throughout the year you have any questions regarding your CCP learning, it is important to contact the MARRT for assistance.
- If you have been audited and are unable to submit your portfolio on time it is important to communicate with the Practice Consultant (practice.consultant@marrt.org) as to the reasons why in advance of the deadline.
- It will be at the discretion of the Registration & Quality Assurance Committee whether to grant an extension.

What happens if I say NO to participating in CCP?

Members who refuse to comply with the legislated requirement cannot proceed with license approval and or renewal.

What happens if I submit an incomplete professional portfolio?

The MARRT Registration Committee will work collaboratively with you to develop a remediation plan for successful completion of the portfolio.

Where can I get more information on the CCP requirements?

The <u>CCP Registrant Guide</u> provides all information regarding the various categories of recognized learning.
